Sunday, 6 November 2022 - 11 Rabi Al-Akhir 1444 Hijri.

Venue: Shahnai Restaurant Hall

An All-America meeting was held on Sunday, 6 November 2022 - 11 Rabi Al-Akhir 1444 Hijri at Shahnai Restaurant Hall, Hillcroft, Houston, under the patronage of the great Islamic scholar Allama Qamar-ul-Zaman Khan Azmi, Secretary General World Islamic Mission UK. After discussions in the context of America, the following issues were agreed upon.

Consensual decisions

- (1) A central meeting of the scholars of Ahl-e-Sunnah was held in which a detailed discussion was conducted regarding the proof of the sighting of the crescent moon in the United States.
- (2) According to the scholars of Hanafiyya, the difference of horizon is not valid unless it is far-fetched.
- (3) If the moon is visible according to an observatory in a country where there is a board of authoritative Ahl al-Sunnah scholars or a religious scholar that is capable of issuing fatwa, then Istifaza Khabr can be done on the sighting of the scholars or the board, or the testimonies. In the case of aforementioned Istifaza Khabr being reported to the United States, an announcement could be made.
- (4) Remember! Only Sunnis with correct beliefs will be allowed to do Istifaza.
- (5) The Board will make the announcement. An individual's personal declaration will be unreliable.
- (6) Istifazah Khabar will be done before the start of Isha. In the form of not receiving news, "completion of 30 days" will be announced after the end of the Isha prayer.
- (7) In the case of California and New York, if the observatory reports that the moon will be visible and the sky will be clear, the decision will be delayed. However, if the sky is cloudy, then "completion of 30 days" will be decided and announced.

The aforementioned issues were agreed by consensus. The Ulema-e-Karam signed their endorsements.
